## OVERVIEW

The Mid City East communities of Bates/Truxton Circle, Bloomingdale, Eckington, Hanover, LeDroit Park, Sursum Corda Area, as well as portions of Edgewood and Stronghold lie north of the U.S. Capitol. These architecturally interesting and culturally vibrant urban neighborhoods are rich with community, but wrestling with concerns – traffic, aging sewer systems, and increasing needs for diverse, affordable and convenient housing, retail and transportation options. The Mid City East Initiative will strive to improve mobility, enhance commercial corridors, promote safety, preserve historic resources, promote green infrastructure, and cultivate development opportunities.

## TIMELINE AND PROCESS

The planning process for the Mid City East Small Area Plan and Livability Study will be highly interactive. The Office of Planning (OP) and District Department of Transportation (DDOT) will host engaging public meetings, office-hours and meet-ups, as well as online activities.

An Advisory Committee made up of representatives from local ANCs, institutions, businesses and civic associations, will provide guidance to the District's teams throughout the process. DDOT's Livability Study will conclude with implementable actions to improve streets in the community. OP's Small Area Plan process will conclude with opportunities for formal public review and comment prior to submission to Council for plan adoption in 2014.

**Small Area Plan:** OP's Small Area Plan will develop goals and recommendations for Historic Resources and Conservation, Parks and Open Space, Commercial/Retail Revitalization, Redevelopment and Housing, Sustainability and Stormwater, Urban Design and Public Realm, and Transportation. The purpose OP's Small Area Plan is to identify specific actions and responsible partners, and to influence future capital planning and development efforts. The central benefit of the plan will be building community consensus, and having a final document that is approved by Council.



**Livability Study:** Concurrent with OP's small area planning effort, DDOT is developing strategies for the neighborhood streets of Mid City East to provide safe pedestrian and bicycle access to transit and community amenities; reduce cut-through traffic and speeding on local neighborhood streets; and enhance landscaping to minimize stormwater runoff.
